## PARTICIPANT WAIVER AND HOLD HARMLESS AGREEMENT

I hereby expressly and knowingly release, covenant not to sue, and forever discharge the Released Parties (as defined below) of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation in the activity of rock climbing and any related activities at, within and/or sponsored by the Rockgym. I further voluntarily and knowingly agree to indemnify and hold each of the Released Parties harmless from and against any and all such liabilities, claims, actions, damages, costs or expenses including, but not limited to, all attorneys' fees and disbursements up through and including any appeal, which may arise out of my participation in the Rock Climbing Activities at, within and/or sponsored by the Rockgym. I further understand that this release and indemnity includes any claims based on the negligence, action or inaction of any of the Released Parties and covers bodily injury (including death), property damage and loss by theft or otherwise suffered by me, either before, during or after such participation. For the purposes hereof, the "Released Parties" are Albany's Indoor Rockgym, Inc., it's manager, officers, directors, employees, agents, contractors, sub-contractors, representatives, successors, assigns and volunteers, and if applicable, any event sponsors and each of their respective parent, subsidiary, affiliated or related companies.

This Participant Agreement, Waiver and Release Form shall be governed by the laws of the State of New York, and any legal action relating to or arising out of this Participant Agreement, Waiver and Release Form shall be commenced exclusively in the Supreme Court of the State of New York in and for the County of Albany, (or if such Supreme Court shall not have jurisdiction over the subject matter thereof, then to such other court sitting in such county and having subject matter jurisdiction). This agreement may not be modified orally, and a waiver or modification of any provision shall not be construed as a waiver or modification of any other provision herein or as a consent to any subsequent waiver or modification. If any term or provision of this Agreement is held to be void or unenforceable, that term or provision will be severed from this Agreement, the balance of the Agreement will survive, and the balance of this Agreement will be reasonably construed to carry out the intent of the parties as evidence by the terms of this Agreement.
